We consider it proper that all expenses which may be incurred in connection with the visit of Their Royal Highnesses to India, with effect from the date of their landing in Bombay until the date of their embarkation for England, so long as they are not the recipients of independent or private hospitality, should be met from Indian Revenues, and we recommend this proposal for Your Lordship's sanction.
